Press Information Contents and Sources

Methodology

For the processing of press news there are daily processed on our database all the businesses news that might be relevant. They are just loaded once; this is to say that if the same piece of news is published in several media we would just load one. News are not entirely copied, our specialists are in charge of summarizing them to optimize the necessary time to know all news.

The date and media from where it was extracted is shown with the piece of news. In the case of a printed edition the page number is provided, in the case of a digital press media the Url is provided to access to the entire news item.

What type of information do we process? How is it structured?

1.- Legal Notices:

Legal Announcements: All agreements reached in a meeting as well as the announcements of dissolution / liquidation and insolvency proceeding meetings.

2.- Financial information:

Financial Data: Economic data, individual, consolidated, annual or for a specific period, debts, investments in general and dividends payments.
Information on Startups, Joint Ventures, Financing Rounds and Crowdfunding.

3.- Informative data:

Agreements between companies: Agreements that imply business.

Business Strategy: Articles on an OPA (Takeover bids), OPV (Initial public offering), OPS (public subscription offer).

General Information: General data about companies that are not classified in the rest of announcements.

Stock Market Information: Additions and removals from trading markets. Variations in market quoting are not collected.

ESG Information: Information on environmental, social and corporate governance issues.

- **Information on Certifications** Information on any certification received by the company in any business environment: AENOR, Family-Friendly Company, etc.
- **Labour Information** Composition, relocation and staff increases as well as work contracts conversions.

4.- Negative information:

Cessation of Business/Activity: Articles related to Dissolutions and Liquidations, information on cease of activities and businesses closings.

Insolvency Proceedings: Articles and edicts containing Bankruptcy / Suspension of Payments / Creditors' meeting and Debt Restructuring Procedures.

Labour Incidents: Labour force adjustment plans (EREs), Temporary labour force adjustment plans (ERTEs), dismissals, non-payments of salaries and that information in which ceasing production is communicated.

5.- Structural data

Shareholders and Participations: Shares and participations purchase and sale, subsidiaries creation.

Principals: Appointments and resignations of the different existing functional managers.

Governing Bodies: Appointments and resignations of members of the governing bodies.

Branches: Branches opening, renting, closing, sale of factories, new establishments.

6.- Business Lines

Market share: Percentage of market share that the companies have in their respective sectors as well as the position that they have in the ranking depending on different criteria (sales volume, profits, etc...).

Production Data: Production data of the Company and its production centres.

Marketing: Advertising investments and advertising account awards.

Business Awards: Awards related to the company's activity or its products, not including the administrators of the Company.

Products and Activities: Launching new products, diversification of new activities and creation of divisions that do not imply the creation of new companies.

Participation in Trade Fairs/Business Events: The presentation of a specific event when it comes with information about the company.

7 - Information on Grants and Awardings

Grants Information From the grant application to its awarding as well as repayment in the event of non-compliance with the agreed conditions.

Awardings information: The award of works and services contracts, together with their submission. From the tender up to the definitive awarding as well as its non-performance.
